The President of the Republic of Uzbekistan, Shavkat Mirziyoyev, in his speech at the inauguration ceremony on November 6, 2021, proposed constitutional reforms and additions and amendments to it. According to Article 127 of the Constitution of the Republic of Uzbekistan, if one-third of the members of the Legislative Chamber and the Senate vote their positive answer to this proposal, they can amend the Constitution through a referendum. And he emphasized that the articles of our Constitution that are relevant to our region will not change. Taking into account the changes taking place in our country at the moment, it is a fact that changes are being made to the Constitution of our country, which protects the well-being of our country and the peace of our people.

The Constitution of the Republic of Uzbekistan was adopted on December 8, 1992. A little less than 31 years later. Considering the future of the people of our country and the tomorrow of the young generation, our honorable president and the Cabinet of Ministers are making a number of changes. Additions are being made to existing regulations. In a word, our respected president is working tirelessly to justify the trust of our people in our country's leader. Currently, we have added additional

articles and laws to our Constitution for the youth. In particular, if the decision "The child is also responsible for the fault committed by the father" exists in our Constitution, the change of this decision to this day ensures the peace and satisfaction of the population of our nation. In addition, we can say that our country takes the young generation under its protection. Among them are several articles on the rights of young people. They provide for personal, political, cultural, economic and social protection of young people. The youth of our country are encouraged not to be indifferent to any changes, to have their place in the life of the society and the state, and to constantly actively participate. Conditions are being created for creative, social, physical and moral formation, education, employment, employment of every person, health care of every citizen and realization of their rights to rest. Constitution is such a power that can make a state a state and a nation a nation. The support of society, the legal guarantee of the development of our country. It is a political document that serves as a foundation for a bright future, prosperous and peaceful life of our multi-ethnic nation.

On February 8, the Law "On Amendments to the Constitution of the Republic of Uzbekistan" was adopted in our country, and this law entered into force from the day it was announced to the public. At the eleventh plenary session of the Senate of the Oliy Majlis of the Republic of Uzbekistan held on January 6, 2021, at the initiative of the head of our state, the supremacy of constitutional law in our country, protection of the rights of citizens in accordance with the laws and regulations established in the constitution It was mentioned that it is necessary to worry about. The necessity of establishing justice in the society, ensuring equality among people, reforming the judicial and legal sphere from the beginning, and solving the problematic issues that have not yet been solved, our honorable president has emphasized in his many decrees and decisions, as well as adding new codes and re-editing the old ones. More than 220,000 proposals and statements made by citizens during the previous period, on November 24, 2022, at the session of the Legislative Chamber, a number of proposals made by deputies and political parties were analyzed by the responsible committees and reflected in the draft Constitutional law.

On June 25, on the "This is my Constitution" portal, the draft law on amending the constitution was published in Uzbek and Russian languages for public discussion. The project was unanimously adopted by the Legislative Chamber of the Oliy Majlis in the first reading. As we reported earlier, the 46-member constitutional commission for the reform of the Constitution developed a draft document within a month. More than 60,000 proposals from citizens and organizations were received through the portal. At the meeting of the lower house of the parliament held on Friday, it was said that the commission will continue to collect proposals and will summarize them and present them to the deputies for discussion. Discussion will last 10 days - until July 4. The final draft of the constitutional law will be put to a referendum.

In the appeal of the Legislative Chamber, it is noted that the draft envisages introducing more than 200 amendments to 64 articles of the Constitution. In addition, 16 new norms with 6 new articles are being introduced. The lower house of the Parliament called on citizens to actively participate in the discussion: "It is important for everyone to call this document mine, My Constitution, and to see in it the solution to the problems that have troubled him, his family, his neighborhood, society and the state for years. The future of the country and the fate of our Motherland depend on you and our active participation in this process, which is of great importance for our future development

It is necessary for each person to make a positive assessment of our Constitution, which is being amended, based on his own point of view. The reason is that the main goal of these changes is to establish "New Uzbekistan" in our country, and the whole nation is united towards one goal, and of course we must contribute. As we step into the "Third Renaissance", an important change in the life of our people, we need to welcome the "New Uzbekistan" with "new projects, new changes, developments, growth " and our goals are before us. It is very important for us to include our developing country among the countries of the world, and we are working tirelessly to do so. In our country, within 5-6 years, they are taking a completely new approach to ensuring the educational potential of citizens:

- improvement of upbringing and education of children of preschool age;
- providing free, compulsory and high-quality education for all;
- guaranteeing conditions for equal use of opportunities for participation in initial and continuing education, aimed at learning to develop appropriate learning, life skills for adults, and the inclusion of vulnerable and disadvantaged groups in need of support at all levels of education issues of assistance to the involvement are being considered. Also, several articles of the constitution are as follows

Point 15 "The Constitution of the Republic of Uzbekistan has supreme legal force in the entire territory of the country, is directly applicable and forms the basis of the legal space."

Point 19 "Human rights and freedoms belong to everyone from birth."

Point 21 "No one can be imposed an obligation not defined by law without his consent."

Point 23 "A citizen of the Republic of Uzbekistan cannot be forced out of Uzbekistan or extradited to another country."

Point 28 "If a person's guilty plea is the only evidence against him, he cannot be found guilty or punished."

Point 29 "Everyone is guaranteed the right to qualified legal assistance."

Point 33 "The state creates conditions for ensuring the use of the Internet global information network."

Point 48 "Citizens of the Republic of Uzbekistan have the right to receive the guaranteed volume of medical care at the expense of the state in accordance with the procedure established by law."

And a number of such articles are added and edited. The number of articles in the Constitution of the Republic of Uzbekistan is increasing from 128 to 155, and the number of norms is increasing from 275 to 434. 91 out of 128 articles are being conceptually amended. The text of the constitution has been updated by 65%. This was announced at the meeting of the Legislative Chamber of the Oliy Majlis.

In conclusion, it should be said that constitutional reform is today's demand and tomorrow's guarantee. It is necessary for the people of our country not to be

indifferent to these changes and to be aware of the newly adopted laws. The reason is that the future of each family's child is not only the children's, but we should not forget that the prosperity of our country, peaceful life, peaceful growth, rapid development definitely depends on our constitution and the new laws and regulations in it.
